This role focuses on advancing legislative and policy priorities related to Jordan's Principle, ensuring that legislative and policy frameworks under Jordan's Principle uphold equitable access for First Nations children to essential resources and supports. The successful candidate will conduct indepth research, provide technical and analytical support, and work collaboratively with First Nations leadership, communities, and other key stakeholders to implement the mandates and resolutions of the Chiefs in Assembly.

## **Typical Duties and Responsibilities:**

#### Your role

- Manage projects and deliverables.
- Work independently with minimal direct supervision.
- Lead environmental scans, analyze policies, and identify gaps impacting First Nations children.
- Contribute to the development and legislative advocacy of policies, strategies, and processes related to Jordan's Principle in the health, social, and education sectors.
- Research and evaluate existing laws, regulations, policies, and processes to identify impacts on First Nations children.
- Prepare comprehensive reports, briefing materials, and presentations for stakeholders.
- Analyze and interpret data to support decision-making and policy development.
- Coordinate and advise on legislative reviews, ensuring alignment with Jordan's Principle objectives.

- Work closely with internal and external stakeholders, including provincial and federal governments, First Nations Communities, First Nations leadership, and health professionals.
- Chair and participate in committees, working groups, and stakeholder meetings as required.
- Perform other related duties as assigned to support organizational goals.

- Collaborate with FSIN staff, health, social and education development professionals, and government officials in relation to legislation and policy initiatives.
- Liaise with First Nations communities to ensure legislative and policy provisions under Jordan's Principle are effectively understood and applied.
- Partner with legal, academic, and professional experts to address challenges and advance solutions.
